## **Feedback**

The October issue of Village matters was encouragingly well received - a warm thank-you to all those kind people who said nice things about it. A single voice rose in protest, not on literary or ethical grounds, but, of all things, for accounting reasons. Jeff Robinson, who watches over the Village's financial probity with eagle eye. wrote, more in sorrow than in anger, a preciselyargued six-page letter to the Chairperson of the Parks Village Residents Association expressing his concern at the proposed (at the Christmas Dinner) "subsidy to the tune of \$7 per head from residents' funds" To say that the cost of the dinner would be subsidised to the tune of \$7 is the same thing as giving each resident a bonus of \$7 and that is forbidden by the constitution of the Association. Moreover, if any of its funds are distributed to members, an association loses its non-profit status and becomes a trading entity, liable for all sorts of horrors including income tax and GST.

The Chairperson, more in anger than in sorrow, rounded on the Editor for landing him in the proverbial, and it took all the diplomatic skills of our wife to restore a semblance of domestic harmony. In due course a most amicable modus vivendi was reached in discussion with Jeff, a central premise of which was that, come Christmas, if all went to plan, there would not be any Parks Village Residents' Association to worry about. The Editor is duly contrite and pleads in mitigation that he was simply exercising his editorial prerogative of resorting to a little hyperbole in order to entertain his readers whilst informing them. The naughty word subsidy or bonus is not mentioned in any minutes, so here endeth a storm in a teacup.

#### Incorporation

You should have received a calling notice to a meeting of residents on 16 November. The main purpose of the meeting is to give you the

opportunity to vote on whether you wish to replace the present Parks Village Residents Association, an unincorporated association, with The Parks Lifestyle Village Residents Association Incorporated. (You can have a better name if you can think of one – but it must end in Incorporated or Inc.). Please do your very best to come to this important meeting. If you cannot come, appoint a proxy to vote for you. Just give them a note saying "I appoint (name of proxy) to be my proxy and vote for me at the meeting of residents on 16 November 2005" – and sign the note. One vote per resident at this meeting, not one vote per unit – people, not bricks and mortar, are voting on incorporation.

183 residents attended the AGM the other day. Allowing for those who, properly, apologised for their absence, that means that something like a fifth of the Village simply ignored the AGM. That is not good enough for the incorporation meeting which will take decisions affecting every resident. Let the record show that by presence or by proxy every one of us had a say in how we organise our corporate affairs.

## **Annual General Meeting**

The Administering Authority's AGM went better than many of us had dared to expect. Our tactic of submitting a co-ordinated list of questions produced a surprisingly detailed response from Lifestyle. That is not to say that their figures are beyond reproach but rather that the Residents' Committee has now got something to work on and we shall be working on them during the coming weeks and months. Stephen Norris has a convincing mike-side manner. It would not do to be taken in by his affable response to questions. We shall be looking for more concrete evidence of a change of heart in Lifestyle's response to Village concerns. There are grounds for a measure of optimism in his apparently genuine surprise that communication between Lifestyle and Village is as deplorable as we know it to be. We shall watch closely for evidence that there has been a change of action if not of heart from management. We understand where the problem lies. Possibly Stephen Norris has a better understanding now but whether he can do anything about it remains to be seen. We have other avenues to explore if we see no improvement - not least the intensifying scale of activity in the political arena. Previous attempts to strengthen the Retirement Villages Act have fizzled out. The current attempt has more promising credentials, notably the imminence of a state election coupled with the growing strength of grey power. It could evolve to our advantage.
